

ORDINANCE NO. 13

AN ORDINANCE PROVIDING FOR "NO PARKING" RESTRICTIONS AT SEVERAL LOCATIONS WITHIN DAVIS COUNTY

BE IT ORDAINED BY THE DAVIS COUNTY BOARD OF SUPERVISORS OF DAVIS COUNTY, IOWA, AS FOLLOWS:

SECTION ONE: That pursuant to and in accordance with Davis County's Home Rule powers vested in it by Section 331.301 of the Iowa Code; that in efforts to better protect and preserve the peace, safety, health, welfare, comfort and convenience of its residents and not inconsistent with the acts of the General Assembly or the Iowa Constitution; that it is unlawful to park at any time of the day or night any vehicle upon the following locations:

1. Upon the North side of 180th Street from the South quarter corner of Section 6, T69N, R13, located on State Highway 63, going easterly along 180th Street for 350 feet;
2. Upon the North side of 160th Street from the South quarter corner of Section 30, T70N, R13W, located in State Highway 63, going westerly along 160th Street for 300 feet;
3. Upon both sides of 195th Street from the Center of Section 18, T69N, R13W, going easterly for 1,200 feet;
4. Upon both sides of Ice Avenue from the intersection of Ice Avenue and 200th Street, going southerly for 3000 feet;
5. Upon the North Side of 280th Street from the intersection of 280th Street with Dewberry Avenue, going westerly to the intersection of 280th Street and Clay Avenue.

SECTION TWO: Violation and Penalty. Any person violating or permitting the violation of any provision of this Ordinance shall upon conviction in Magistrate Court be fined a sum not more than \$100.00 or the Court may sentence the Defendant to imprisonment in the Davis County jail for a period not to exceed thirty (30) days.



SECTION FOUR: Severability Clause. If any sections, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision, or part thereof not adjudged invalid or unconstitutional.


SECTION FIVE: When Effective. This ordinance shall be in effect from and after its final passage, approval and publication as provided by law.


