The Davis County Board of Supervisors met in regular session on Monday, October 16, 2017, with Chairman Ron Bride and Members Matt Greiner and Alan Yahnke present.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Monday, October 9, 2017.

The Board met with custodian Randy Norman, who reported concerning lock changes for the courthouse.

The Board met with Engineer Ryan Schock, who reported that 2,385 tons of rock were hauled last week and striping project was started last week east of Drakesville.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve Annette Raebel as full time payroll/accounts payable Clerk in the Auditor's Office with accompanying pay increase.

Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to approve annual contract with Cost Advisory Services, Inc.

After discussion, Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to contract for installation of Christmas lighting on courthouse downspouts and the gazebo.

Sheriff Davis requested Law Center gutter improvement work due to soil erosion on the west side of the building. It was agreed that John Hansen will be called concerning the matter.

After discussion, Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to approve sending a letter to the Iowa Director of Farm Service Agency and to U.S. Representative Dave Loebsack requesting correction of erroneous drought monitoring data for Davis County.

During committee reports, Matt Greiner reported on meeting with the Senior Center; Alan Yahnke reported on Board of Health meeting; and Ron Bride reported on meetings with South Central Behavioral Health Region and Mutchler Community Center.
