The Davis County Board of Supervisors met in regular session on Monday, October 1, 2018, with Chairman Matt Greiner and Members Ron Bride and Alan Yahnke present. Ernie Bohi spoke to the Board during public comments.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, September 24, 2018.

The Board met with Judy Combs; Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to act as pass-through fiscal agent for a tourism grant.

The Board met with custodian Randy Norman, who told the Board that the elevator passed inspection and is now working. He met with the Christmas lighting company and repaired a broken window at the VA building.

The Board met with Engineer Ryan Schock, who reported on bridge projects and safety shouldering project to begin north of Drakesville. Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve Rushing and Brendes utility permits for Citizens Mutual Telephone; Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve Russel utility permit for Citizens Mutual Telephone.
