The Davis County Board of Supervisors met in regular session on Monday, November 26, 2018, with Chairman Matt Greiner and Members Ron Bride and Alan Yahnke present.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, November 19, 2018.

The Board met with Roger Wuthrich and Shannon Besely, who reported on use of the public library and the need for more financial support.

The Board met with custodian Randy Norman, who informed the Board concerning snow removal and Christmas lights.

The Board met with Engineer Ryan Schock and received updates on bridge projects, fiber optic installations, lagoon dirt work at the county farm, and a request for a letter of support from the Board for a grant application. They also met with Melvin Schrock, Joe A. Mast, Dave Schrock, and Sam Schrock concerning horse and buggy use of the roads and possibility of voluntary contributions to the county for such use. After discussion, Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to enter into a 28E Agreement with West Grove Township to park county equipment on township property.

Ron Bride made motion, seconded by Alan Yahnke and, by roll call vote, carried unanimously, to go into closed session to discuss a county employee, pursuant to Iowa Code Section 21.5(i). Thereafter, Alan Yahnke made motion, seconded by Ron Bride and, by roll call vote, carried unanimously, to come out of closed session and return to regular session. No further action taken at this time.

Ron Bride reported on committee meetings attended.
