The Davis County Board of Supervisors met in regular session on Monday, January 14, 2019, with Chairman Alan Yahnke and Members Matt Greiner and Ron Bride present.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, January 7, 2019. The Board took note that the Minutes of January 2, 2019, as published, contained a typographical error, and the names of Virginia Rysdam and William Kunzman were erroneously stated as members of the Real Estate Compensation Commission instead of Kimberly Fleming and Alan Janssen.

The Board met with custodian Randy Norman, who reported that the sidewalks had been cleared after the weekend snow storm and Christmas décor has been put away.

The Board met with Engineer Ryan Schock, who reported that snowplows and bladers had worked on Saturday and Sunday removing snow from the weekend storm. The DOT has awarded a \$260,000 project for fall construction of centerline rumbles on seven roads and edge-line rumbles on four roads.

After discussion, Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve a new lease agreement for the County Farm, with bids to be due February 8, 2019, and opened on February 11, 2019.

After discussion, Ron Bride made motion, seconded by Matt Greiner and carried unanimously, to sign a contract with Area 15 Regional Planning Commission for grant application services.

The Board met with Mike Atkins of Midwest Construction Consultants, who explained various possibilities for repair or replacement of the heating and cooling systems at the County Home. He recommended hiring an engineer to design some different avenues and costs. No action taken.

All Board members reported on committee meetings attended.

The Board reviewed office budgets with Auditor Linda Humphrey.
