The Davis County Board of Supervisors met in regular session on Monday, January 15, 2018, with Chairman Matt Greiner and Members Ron Bride and Alan Yahnke present.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Monday, January 8, 2018.

NOTE: correction to Minutes of January 2, 2018: Virginia Rysdam and William Kunzman were previously replaced on the Real Estate Compensation Commission by A. J. Brown and Rod Lynch.

The meeting with custodian Randy Norman was cancelled but discussion of tree removal was held. Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to hire Southern Iowa Tree Service, who provided the lowest estimate.

The Board met with Engineer Ryan Schock, who reported on various bridge projects, and that request for \$58,000 reimbursement has been sent to FEMA. Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve Resolution to set letting date for bridge replacement on 220th Street in Section 33-69-15 for February 5, 2018, at 9:00 a.m.

Discussion was held concerning cost of Waste Management services; no action taken.

Discussion was held concerning method of disposal of county car and decision was made to advertise for bids to sell same.

Discussion was held concerning possible contract with Iowa State Association of Counties for continuing assistance with HIPAA compliance. Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to sign contract for \$1,950.00 or less.

During committee reports, Matt Greiner reported on meeting of Workforce Development; Ron Bride reported on meetings of Emergency Services Association, 8th Judicial District, and Regional Service Agency; Alan Yahnke reported on meeting of Decategorization Executive Committee.

The Board reviewed proposed office budgets with Auditor Linda Humphrey.
