The Davis County Board of Supervisors met in regular session on Monday, February 6, 2017, with Chairman Ron Bride and Members Matt Greiner and Alan Yahnke present. Public comments were received from Nancy Clancy and Ken Turner.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda. Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to approve and sign the Minutes of Monday, January 30, 2017.

The Board met with custodian Randy Norman, who reported on repairs to the courtroom doors and courtroom lighting.

The Board met with Secondary Roads; Assistant Engineer Ryan Schock reported on bridge repair projects. The Nuthatch Avenue bridge was re-opened last week. Bids for Quince Boulevard bridge project were opened; Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to accept the low bid of Bloomfield Bridge & Culvert, subject to review of figures.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve Resolution setting trip permit prices, copy of which is on file in the Auditor's Office.

The Board met with Nancy Clancy and discussed mowing problems at the guerilla raid monument; she requested that a retaining wall be built to eliminate mowing; no action taken.

The Board discussed funding of the employee health plan fund with Auditor Linda Humphrey and requested that she prepare a resolution to borrow money if necessary.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve the proposed Law Center lease agreement with the City of Bloomfield.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to appoint Earl Trachsel to fill the vacant position of Prairie Township Trustee as the previous appointee is not a resident of Prairie Township.

Alan Yahnke reported on Board of Health meeting he attended.
