The Davis County Board of Supervisors met in regular session on Monday, July 30, 2018, with Chairman Matt Greiner and Members Ron Bride and Alan Yahnke present.

The Board met with John Schroeder, Director of Davis County Development Corporation, who invited the Board to attend a meeting on October 18 with a speaker who is very knowledgeable about TIF.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Monday, July 23, 2018.

The Board met with custodian Randy Norman, who reported on the elevator upgrade and mentioned possible window tinting for east courthouse windows and possible new tree plantings in the north courtyard.

The Board met with Engineer Ryan Schock, who reported on progress of bridge projects and completion of Floris Road patching. Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to sign contracts for the Matheny box culvert. Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to sign utility permit for Interstate Power and Light. Dale Taylor requested assistance in tree removal at the cemetery at the County Farm, and the Engineer agreed that Secondary Roads would remove it.

Assessor Lois Heckethorn is gathering information concerning property values of wind towers to estimate revenue production should wind farms be established in the county.

All Board members reported on committee meetings attended.

At 1:00 p.m. the Board reconvened to conduct Courthouse Security Committee meeting.
