The Davis County Board of Supervisors met in regular session on Monday, September 24, 2018, with Chairman Matt Greiner and Members Ron Bride and Alan Yahnke present.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Monday, September 17, 2018.

The Board met with custodian Randy Norman, who reminded the Board that the elevator inspection will be tomorrow.

The Board met with Engineer Ryan Schock, who reported on progress of bridge projects, and that the easement with West Grove Township to park maintenance equipment is still awaiting signatures. He also presented the following resolution to re-locate a stop sign at Balsa Avenue and 274th Street:

The Board of Supervisors is empowered under the authority of Sections 321.236, 321.255, and 321.345 of the 2005 Code of Iowa to designate any highway under their jurisdiction as a through highway and to erect STOP and YIELD signs, in accordance with specifications established by the department at specified entrances to the highway or may designate any intersection as a stop intersection or as a yield intersection and erect like signs at one or more entrances to such intersections.

Whereas: The traffic pattern through the intersection of 274th Street and Balsa Avenue has changed and the geometry of the intersection is such that the Board of Supervisors is re-locating the existing stop sign on 274th St for east bound traffic to stop the south bound traffic on Balsa Avenue.

Whereas: The traffic traveling south on Balsa Avenue shall stop at the intersection with 274th Street. Now, therefore, BE IT RESOLVED by the Davis County Board of Supervisors that for the safety of the traveling public a STOP sign shall be re-located at the intersection of 274th Street and Balsa Avenue in section 30-68-15.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve the above resolution.

The Board met with Main Street Director Tammy Roberts, who explained expansion of the Main Street area for further community outreach.

The Board met with Recorder Megan Clyman and discussed the current contract for the new county website design and the scope of work progress.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve the second reading of proposed Ordinance #27 regarding assessment of wind energy conversion property, a copy of which is in the Auditor's Office.

Discussion of courthouse Christmas lights was tabled until next week.

All Board members reported on committee meetings attended.
