The Davis County Board of Supervisors met in regular session on Monday, September 26, 2016, with Chairman Matt Greiner and Members Dale Taylor and Ron Bride present.

Nancy Clancy and Ken Turner commented about streetscape during public comments; Barbara Hird invited the Board to a ribbon cutting at Lake Wapello this Friday at 8:30 a.m.

Ron Bride made motion, seconded by Dale Taylor and carried unanimously, to approve the agenda.

Dale Taylor made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, September 19, 2016.

The Board met with custodian Randy Norman, who reported on work he has done and problems needing attention; he also discussed the new handicap accessible door at the VA/SIEDA building

The Board met with Secondary Roads; the Engineer reported on progress on the Apple Avenue bridge; that FEMA denied the appeal concerning Fig Avenue bridge; and Quality Striping had the low bid for painting.

The Board met with Megan Clyman, who asked permission for the Young Professionals and other volunteers to decorate the courtyard at Christmas; Ron Bride made motion, seconded by Dale Taylor and carried unanimously, to approve same.

At 10:00 a.m. public hearing was held to update the public on the status of disaster recovery infrastructure/watershed protection project funded by the US Department of HUD/Community Development Block Grant program. Chris Bowers from Area XV Regional Planning presented the following project updates. Davis County was awarded \$1,594,620 in July 2013, and nearly all planned installations have been completed, including 22 grade stabilization structures and 101 water and sediment control basins. There were four construction bid lettings and work was divided into fifteen divisions for bidding purposes. There being no public or written comments, Ron Bride made motion, seconded by Dale Taylor and carried unanimously, to close the hearing.

Discussion concerning employee wellness and health screenings was tabled.

Second reading of the weapons ordinance was held, and Ron Bride made motion, seconded by Dale Taylor and carried unanimously, to waive the third reading. Dale Taylor made motion, seconded by Ron Bride and carried unanimously, to adopt Ordinance #26.

Ordinance # 26 is hereby enacted and in effect as of September 26, 2016, in the following form:

#### ORDINANCE PROHIBITING DANGEROUS WEAPONS AT SIEDA SITE

The purpose of this ordinance is to provide for the safety and enjoyment of certain county facilities as weapons-free areas and to comply with federal regulations and requirements in regard thereto.

For use in this ordinance, "dangerous weapon" is defined as any instrument or device designed primarily for use in and is capable of inflicting death or injury upon a human being or animal. Dangerous weapons include, but are not limited to, any offensive weapon as defined in Iowa Code Section 724.1, including pistol, revolver, or other firearm, dagger, razor, stiletto, switchblade knife, or knife having a blade exceeding five inches in length.

No person shall carry a dangerous weapon in or onto the facility occupied by Southern Iowa Economic Development Association (SIEDA) at 203 S. Madison Street, Bloomfield, Iowa, unless the person meets the conditions of an exception listed below. The prohibitions of this ordinance apply whether or not the person possesses a valid Iowa permit to carry weapons.

It is not a violation of this ordinance for a person to carry a dangerous weapon in or onto the SIEDA facilities if the person:

- a. is a peace officer as defined in Iowa Code Section 801.4; or

- b. is a member of the armed forces of the United States or of the National Guard, when the person's duties or lawful activities require possession of a dangerous weapon in or on these facilities; or
- c. possesses a valid Iowa professional permit to carry a weapon and the person's duties require carrying a dangerous weapon in or on these facilities; or
- d. possesses a dangerous weapon for any purpose authorized by a state agency to further the statutory or regulatory responsibilities of that agency.

Violation of this ordinance constitutes a simple misdemeanor. In addition, any person believed to have violated this ordinance may be denied access to this facility and the weapon may be confiscated. Additional applicable criminal charges may also be filed.

Adopted and passed by the Davis County Board of Supervisors on this 26 day of September, 2016.

Election pay change issue was not considered.

During committee reports, Dale Taylor noted that Southern Iowa Mental Health is moving to the old Target building in Ottumwa, and 10-15 Transit is moving to new headquarters. Ron Bride reported concerning meetings of South Central Behavioral Health Region, Main Street, Wapello Landfill, and SIDCA, which has received approval for another Wyacondah project. Matt Greiner reported on Davis County Hospital Foundation meeting.

Ron Bride made motion, seconded by Dale Taylor and carried unanimously, to approve the following claims to be paid:
