The Davis County Board of Supervisors met in regular session on Monday, April 29, 2019, with Chairman Alan Yahnke and Members Matt Greiner and Ron Bride present.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, April 22, 2019.

The Board met with custodian Randy Norman, who reported that he had gotten a quote for deep cleaning and sealing the floor in the courthouse; he was authorized to have the work done. He also discussed courtyard trees and verified that the new tree will be planted at the marked location on the north of the courthouse.

The Board met with Engineer Ryan Schock, who gave progress reports on bridge projects and presented an application for TSIP funds in the amount of \$75,000 for guardrail across Lake Fisher road; Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to sign same. Matt Greiner also made motion, seconded by Ron Bride and carried unanimously, to sign utility permit for Southern Iowa Electric, pending approval of the County Engineer.

The Board met with Todd VanSike, who gave them a woodburned likeness of the courthouse that he had created.

Two staff members from Marsy's Law for Iowa presented a resolution for the Board's approval. After discussion, Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve the following Resolution:

A RESOLUTION IN SUPPORT OF MARSY'S LAW A BILL STRENGTHENING VICTIM RIGHTS IN IOWA

WHEREAS there is currently a Bill up for consideration with the Iowa Legislature, identified as Marsy's Law, which provides crime victims with basic and enforceable rights;
WHEREAS the Davis County Board of Supervisors supports such a Bill as being in the best interest of the public;
THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF DAVIS COUNTY that the Davis County Board of Supervisors hereby supports Marsy's Law and urges all citizens to join in this commitment to protect the rights of Iowa crime victims.
PASSED AND APPROVED this 29 day of April, 2019.

The Board met with Sheriff Dave Davis, who requested approval to exceed the \$500 credit card limitation (to be repaid with forfeiture funds) in order to send two deputies to the National Peace Officer's Memorial in Washington, D.C. They will attend a service honoring fallen peace officers, including Davis County's K-9 Eico.
