The Davis County Board of Supervisors met in regular session on Monday, September 9, 2019, with Chairman Alan Yahnke and Members Matt Greiner and Ron Bride present.

Ron Bride made motion, seconded by Matt Greiner and carried unanimously, to approve the agenda, with the exception of meeting with Randy Norman, which has been cancelled.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Tuesday, September 3, 2019.

The Board met with Engineer Ryan Schock, who reported on Beechwood bridge progress; patching on Lilac Avenue began on Saturday and continues this week; the painting portion of the striping project will begin Tuesday.

At 9:45 a.m. Chairman Alan Yahnke called public hearing to order. At that time, first reading of the proposed tanning bed ordinance was held. No public comments were received and Ron Bride made motion, seconded by Matt Greiner and carried unanimously, to close the hearing.

At 10:00 a.m. Ron Bride made motion, seconded by Matt Greiner and, by roll call vote, carried unanimously, to go into closed session to discuss strategy for possible litigation, pursuant to Iowa Code Section 21.5(1)(c). After discussion, Matt Greiner made motion, seconded by Ron Bride and, by roll call vote, carried unanimously, to return to open session. No further action taken.
