The Davis County Board of Supervisors met in regular session on Monday, July 6, 2020, with Chairman Ron Bride and Members Alan Yahnke and Matt Greiner present.

Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to approve the agenda.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Monday, June 29, 2020.

During public comments, a county resident discussed the recent vandalism at the Guerilla Raid Society Memorial, and a complaint was heard regarding law enforcement progress on an ongoing case file.

The Board met with custodian Randy Norman, and general courthouse maintenance was discussed.

The Board met with Engineer Ryan Schock, who reported on current projects, including the Harold Yahnke bridge pavement overlay taking place this week.

The Board met with Abby Yearling, from the Bloomfield Main Street organization, requesting use of the courtyard for “movie night” event, to be scheduled later in July. After discussion, the Board reluctantly denied that request, due to Covid-19 precautions regarding crowd gatherings and general health safety.

Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to approve the quarterly revenue reports, as presented, for the Auditor, Recorder, and Sheriff.

Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to send a letter to all department heads, and others, restating the county’s requested practices for paper recycling.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve a resolution agreeing to provide Area 15 Regional Planning Commission with financial support for Fiscal Year 2021.

All Board members reported that there were no committee meetings attended last week, due to the 4th of July holiday.
