The Davis County Board of Supervisors met in regular session on Monday, August 10, 2020, with Chairman Ron Bride and Members Alan Yahnke and Matt Greiner present.

Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to approve the agenda.

Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to approve and sign the Minutes of Monday, August 3, 2020.

The Board met with custodian Randy Norman, and held general discussion.

The Board met with Engineer Ryan Schock, and Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to approve a resolution for a road vacation public hearing to be held on Monday, August 17, 2020 at 9:00 a.m., regarding the vacation of the entire segment of public road (original and with modifications) commencing at the intersection of Kelp Ave and Lilac Ave and continuing South 0.484 miles (2,555 ft.) and then turning West onto 305<sup>th</sup> Street, for approximately 0.067 miles (350 feet) to the end of the road vacation.

Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to approve a resolution establishing a training reimbursement agreement which requires Deputy Sheriff's to reimburse the County for the expense of training at the Academy, as well as other expenses, if their employment with the county ceases before they have worked as a full-time Deputy Sheriff for four (4) years after graduating the Academy.

Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to approve the agreement regarding the Resolution for Training Reimbursement.

Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to approve the hiring of Kristi Goodson, to the full time position of Office Assistant, in the Auditor's office.

The Board accepted, with regret and appreciation for her years of service, the resignation of Vicki Lough, from her position as Deputy Recorder.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve the decision from the Veterans Affairs Commission to pay Veterans Affairs Director Tisha Scott for additional temporary hours.

The Board tabled the discussion regarding the lease agreement to All American Turf Beauty Inc. for the Christmas lighting.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve the contract with NyHart actuarial firm for mandatory GASB 75 reporting.

Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to “opt-out” of the Wellmark recommendations to extend COVID – 19 allowances.

All Board members reported on committee meetings attended.
