The Davis County Board of Supervisors met in regular session on Monday, September 21, 2020, with Chairman Ron Bride and Members Alan Yahnke and Matt Greiner present.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

In public comments, a county resident voiced his concern that a dust controlled portion of road was bladed through on one end.

Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to approve and sign the Minutes of Monday, September 14, 2020.

The meeting with custodian Randy Norman, was cancelled.

The Board met with Engineer Ryan Schock, who reported on road maintenance projects throughout the county.

Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to approve a resolution to change an earlier resolution vacating a portion of Pike Blvd. The revision slightly extends the footage of the previous resolution, per the landowner request.

Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to approve a utility permit for Southern Iowa Electric Coop., Inc., for a location on 190th & Kelp Ave.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve a utility permit for Rathbun Regional Water Association for a location West of Yukon Ave.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve a contract with Iowa Bridge & Culvert for the bridge project on Mahogany Ave.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve delegating Engineer Ryan Schock to sign in to “DocExpress”, in lieu of the supervisors, for said bridge project on Mahogany Ave.

At 10:00 a.m. budget hearing was held. There being no public comments, Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to close the hearing. Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to approve the budget amendment and as previously published in September 9, 2020 issue of *The Bloomfield Democrat*. Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve the Amendment to the Appropriations Resolution, as follows:
