The Davis County Board of Supervisors met in regular session on Monday, March 8, 2021, with Chairman Matt Greiner and Members Alan Yahnke and Ron Bride present.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

There were no public comments.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Monday, March 1, 2021.

The Board met with custodian Randy Norman, who relayed that he had repaired the heater in the Jury room, and was still working on ceiling tile replacement in the courtroom.

The Board did not meet with Engineer Ryan Schock, as scheduled, but spoke to a liaison from his office regarding general road maintenance and current bridge projects.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to re-appoint both Jesse Bonner and Judy Combs to the Davis County Historic Preservation Commission for a term of 3 years.

The Board met with Tom Prosapio, in his capacity as construction manager for the Courthouse accessibility project. Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve Tom for authorization, without Board approval, for decisions which do not exceed \$1,000 in cost.
