The Davis County Board of Supervisors met in regular session on Tuesday, February 16, 2016, with Chairman Matt Greiner and Members Dale Taylor and Ron Bride present.

Dale Taylor made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

Ron Bride made motion, seconded by Dale Taylor and carried unanimously, to approve and sign the Minutes of Monday, February 8, 2016, after changes.

The Board met with Secondary Roads. Resolution concerning Dill Avenue was tabled until next week because one landowner has not been contacted. Bids were opened for bridge removal projects. Ron Bride made motion, seconded by Dale Taylor and carried unanimously, to award all four projects to Jonathan Nolt, the highest bidder. DOT safety program for striping Timber Avenue, Lilac Avenue, 180<sup>th</sup> Street east of Drakesville, and Ice Avenue south of Drakesville is still under review. Project updates continue for City of Floris bridge.

The County Farm lease was reviewed; no action taken.

Upon motion by Dale Taylor, seconded by Ron Bride and carried unanimously, the proposed Pioneer Cemetery Ordinance was read aloud.

The Board met with Lynn Davidson of Bloomfield Main Street, who requested use of the courtyard on June 25, 2016, for Hairy Nation Days. Ron Bride made motion, seconded by Dale Taylor and carried unanimously, to approve use.
