

## NOTICE OF PRIVACY PRACTICES FOR HEALTH CARE PROVIDERS

**THIS NOTICE DESCRIBES HOW MEDICAL INFORMATION ABOUT YOU MAY BE USED AND DISCLOSED AND HOW YOU CAN GET ACCESS TO THIS INFORMATION.**

**This Notice of Privacy Practices describes how Davis County may use and disclose your protected health information to carry out treatment, payment or health care operations and for other purposes that are permitted or required by law. It also describes your rights to access and control your protected health information ("PHI"). "PHI" is information about you, including demographic information, that may identify you and that relates to your past, present or future physical or mental health or condition and related health care services.**

Davis County is required to abide by the terms of this Notice of Privacy Practices. Davis County may change the terms of this notice, at any time. The new notice will be effective for all PHI that Davis County maintains at that time. Upon request, Davis County will provide you with any revised Notice of Privacy Practices.

### **PERMITTED USES AND DISCLOSURES OF PHI**

Your PHI may be used and disclosed by Davis County for the purpose of providing or accessing health care services for you. Your PHI may also be used and disclosed to pay your health care bills and to support the business operation of Davis County.

The following categories describe ways that Davis County is permitted to use and disclose health care information. Examples of types of uses and disclosures are listed in each category. Not every use or disclosure for each category is listed; however, all of the ways Davis County is permitted to use and disclose information falls into one of these categories:

- 1) **Treatment:**  
Davis County may use and disclose your PHI to provide, coordinate or manage your health care and any related services. This includes the coordination or management of your health care with a third party that has already obtained your permission to have access to your PHI. For example, Davis County would disclose your PHI, as necessary, to a home health agency that provides care to you. Another example is that PHI may be provided to a facility to which you have been referred to ensure that the facility has the necessary information to treat you.
- 2) **Payment**  
Davis County may use and disclose health care information about you so that the treatment and services you receive may be billed to and payment may be collected from you, an insurance company or a third party. Davis County may also discuss your PHI about a service you are going to receive to determine whether you are eligible for the service, and for undertaking utilization review activities. For example, authorizing a service may require that your relevant PHI be discussed with a provider to determine your need and eligibility for the service.
- 3) **Healthcare Operations**  
Davis County may use or disclose, as-needed, your PHI in order to support its business activities. These activities include, but are not limited to, quality assessment activities, employee review activities, licensing and conducting or arranging for other business activities. For example, Davis County may use or disclose your PHI, as necessary, to contact you to remind you of your appointment or to provide information about alternate services or other health-related benefits.

Davis County may share your PHI with third party "business associates" that perform various activities (e.g., billing, transcription services) for Davis County. Whenever an arrangement between Davis County and a business associate involves the use or disclosure of your PHI, Davis County will have a written contract that contains terms that will protect the privacy of your PHI.

### **USES AND DISCLOSURES OF PHI REQUIRING YOUR WRITTEN AUTHORIZATION**

Other uses and disclosures of your PHI will be made only with your written authorization, unless otherwise permitted or required by law as described below. You may revoke this authorization, at any time, in writing, except to the extent that Davis County has taken an action in reliance on the use or disclosure indicated in the authorization.

Davis County also may keep psychotherapy notes. These are given a higher degree of protection and cannot be disclosed without your express permission except to carry out certain treatment, payment, or health care operations including allowing the note taker to use them for treatment, using the notes for training programs, or using the notes in defense of a legal proceeding. You have the opportunity to specifically authorize disclosure of psychotherapy notes on the *Authorization for Release of PHI* form.

We will not use or disclose your PHI for marketing purposes without your written authorization unless the marketing is conducted through a face-to-face communication or involves a gift of nominal value.

We will not accept payment of any kind for your PHI without your written authorization. Sale of PHI is prohibited only as it is defined by law and does not include accepting payment for your treatment.

You may revoke an authorization at any time by notifying us in writing. If this should ever be the case, please be aware that revocation will not impact any uses or disclosures that occurred while the authorization was in effect.

Davis County may use and disclose your PHI in the following instances. You have the opportunity to agree or object to the use or disclosure of all or part of your PHI. If you are not present or able to agree or object to the use or disclosure of the PHI, then Davis County may, using professional judgment, determine whether the disclosure is in your best interest. In this case, only the PHI that is relevant to your health care will be disclosed.

- 1) **Others Involved in Your Healthcare**  
Unless you object, Davis County may disclose to a member of your family, a relative, a close friend or any other person you identify, your PHI that directly relates to that person's involvement in your health care. If you are unable to agree or object to such a disclosure, Davis County may disclose such information as necessary if Davis County, based on its professional judgment, determines that it is in your best interest. Davis County may use or disclose PHI to notify or assist in notifying a family member, personal representative or any other person that is responsible for your care of your location, general condition or death. Finally, Davis County may use or disclose your PHI to an authorized public or private entity to assist in disaster relief efforts and to coordinate uses and disclosures to family or other Individuals involved in your health care.
- 2) **Emergencies**

Davis County may use or disclose your PHI in an emergency treatment situation. If this happens, Davis County shall try to obtain your acknowledgment of receipt of the Notice of Privacy Practices as soon as reasonably practicable after the delivery of treatment.

### **OTHER PERMITTED AND REQUIRED USES AND DISCLOSURES THAT MAY BE MADE WITHOUT YOUR AUTHORIZATION OR OPPORTUNITY TO OBJECT**

Davis County may use or disclose your PHI in the following situations without your consent or authorization. These situations include:

- 1) **Required by Law**  
Davis County may use or disclose your PHI to the extent that the law requires the use or disclosure. You will be notified, as required by law, of any such uses or disclosures.
- 2) **Public Health**  
Davis County may disclose your PHI for public health activities and purposes to a public health authority that is permitted by law to collect or receive the information. The disclosure will be made for the purpose of controlling disease, injury or disability. Davis County may also disclose your PHI, if directed by the public health authority, to a foreign government agency that is collaborating with the public health authority.
- 3) **Communicable Diseases**  
Davis County may disclose your PHI, if authorized by law, to a person who may have been exposed to a communicable disease or may otherwise be at risk of contracting or spreading the disease.
- 4) **Health Oversight**  
Davis County may disclose your PHI to a health oversight agency for activities authorized by law, such as audits, investigations and inspections. Oversight agencies seeking this information include government agencies that oversee the health care system, government benefit programs, other government regulatory programs and civil rights laws.
- 5) **Abuse or Neglect**  
Davis County may disclose your PHI to a public health authority that is authorized by law to receive reports of child abuse or neglect. In addition, Davis County may disclose your PHI if it believes that you have been a victim of abuse, neglect or domestic violence to the governmental entity or agency authorized to receive such information. In this case, the disclosure will be made consistent with the requirements of applicable federal and state laws.
- 6) **Food and Drug Administration**

Davis County may disclose your PHI to a person or company required by the Food and Drug Administration to report adverse events, product defects or problems, biologic product deviations, track products; to enable product recalls; to make repairs or replacements, or to conduct post marketing surveillance, as required.

- 7) **Legal Proceedings**  
Davis County may disclose PHI in the course of any judicial or administrative proceeding, in response to an order of a court or administrative tribunal (to the extent such disclosure is expressly authorized), in certain conditions in response to a subpoena, discovery request or other lawful process.
- 8) **Law Enforcement**  
Davis County may also disclose PHI, so long as applicable legal requirements are met, for law enforcement purposes. these law enforcement purposes include (1) legal processes and otherwise required by law, (2) limited information requests for identification and location purposes, (3) pertaining to victims of a crime, (4) suspicion that death has occurred as a result of criminal conduct, (5) in the event that a crime occurs on Covered Entity premises, and (6) medical emergency (not on Davis County's premises) and it is likely that a crime has occurred.
- 9) **Coroners, Funeral Directors, and Organ Donation**  
Davis County may disclose PHI to a coroner or medical examiner for identification purposes, determining cause of death or for the coroner or medical examiner to perform other duties authorized by law. We may also disclose PHI to a funeral director, as authorized by law, in order to permit the funeral director to carry out their duties. We may disclose such information in reasonable anticipation of death. PHI may be used and disclosed for cadaveric organ, eye or tissue donation purposes.
- 10) **Research**  
Davis County may disclose your PHI to researchers when their research has been approved by an Institutional Review Board that has reviewed the research proposal and established protocols to ensure the privacy of your PHI.
- 11) **Criminal Activity**  
Consistent with applicable federal and state laws, Davis County may disclose your PHI, if it believes that the use or disclosure is necessary to prevent or lessen a serious and imminent threat to the health or safety of a person or the public. Davis County may also disclose PHI if it is necessary for law enforcement authorities to identify or apprehend an Individual.
- 12) **Military Activity and National Security**  
When the appropriate conditions apply, Davis County may use or disclose PHI of Individuals who are Armed Forces personnel (1) for activities deemed necessary by appropriate military command authorities; (2) for the purpose of a determination by the Department of Veterans Affairs of your eligibility for benefits, or (3) to foreign military authority if you are a member of that foreign military service. Davis County may also disclose your PHI to authorized federal officials for conducting national security and intelligence activities, including for the provision of protective services to the President or others legally authorized.
- 13) **Workers' Compensation**  
Your PHI may be disclosed by Davis County as authorized to comply with workers' compensation laws and other similar legally established programs.
- 14) **Inmates**  
Davis County may use or disclose your PHI if you are an inmate of a correctional facility and Davis County created or received your PHI in the course of providing care to you.
- 15) **Required Uses and Disclosures**

Under the law, Davis County shall make disclosures to you and when required by the Secretary of the Department of Health and Human Services to investigate or determine Davis County's compliance with the requirements of 45 C.F.R. section 164.500 et. seq.

## **YOUR RIGHTS**

The following are a list of your rights with respect to your PHI and a brief description of how you may exercise these rights:

### **RIGHT TO INSPECT AND COPY YOUR PHI**

This means you may inspect and obtain a copy of PHI about you that is contained in a designated record set for as long as Davis County maintains the PHI. A "designated record set" contains medical and billing records and any other records that Davis County uses in making decisions about you.

Under federal law, however, you may not inspect or copy the following records; psychotherapy notes; information compiled in reasonable anticipation of, or use in, a civil, criminal, or administrative action or proceeding, and PHI that is subject to law that prohibits access to PHI. Depending on the circumstances, a decision to deny access may be reviewable. In some circumstances, you may have a right to have this decision reviewed. Please contact Davis County Privacy Officer if you have questions about access to your medical record.

### **RIGHT TO REQUEST A RESTRICTION OF YOUR PHI**

This means you may ask Davis County not to use or disclose any part of your PHI for the purposes of treatment, payment or healthcare operations. You may also request that any part of your PHI not be disclosed to family members or friends who may be involved in your care or for notification purposes as described in this Notice of Privacy Practices. Your request must state the specific restriction requested and to whom you want the restriction to apply. Davis County is not required to agree to a restriction that you may request, except in the case of a disclosure you have restricted under 45 C.F.R. §164.522(a)(1)(vi) related to restricted disclosures to health plans if the disclosure is for the purpose of carrying out payment or health care operations and is not otherwise required by law, and the PHI pertains solely to a health care item or service for which you have (or someone other than you but not the health plan has) paid out-of-pocket, in full. If Davis County believes that it is in your best interest to permit use and disclosure of your PHI, your PHI will not be restricted. If Davis County does agree to the requested restriction, it may not use or disclose your PHI in violation of that restriction unless it is needed to provide emergency treatment. With this in mind, please discuss any restriction you wish to request with Davis County. You may request a restriction in writing to Davis County Privacy Officer. To request a restriction, you must provide us, in writing 1) what information you want to limit; 2) whether you want to limit our use, disclosure or both; and 3) to whom you want the limits to apply.

### **RIGHT TO REQUEST CONFIDENTIAL COMMUNICATIONS FROM DAVIS COUNTY BY ALTERNATIVE MEANS OR AT AN ALTERNATIVE LOCATION**

Davis County will accommodate reasonable requests. Davis County may also condition this accommodation by asking you for information as to how payment will be handled or specification of an alternative address or other method of contact. Davis County will not request an explanation from you as to the basis for the request. Please make this request in writing to Davis County Privacy Officer.

### **RIGHT TO REQUEST AN AMENDMENT TO YOUR PHI**

This means you may request an amendment of PHI about you in a designated record set for as long as Davis County maintains this information. In certain cases, Davis County may deny your request for an amendment. If Davis County denies your request for amendment, you have the right to file a statement of disagreement with Davis County and Davis County may prepare a rebuttal to your statement and will provide you with a copy of any such rebuttal. All requests for amendments must be in writing.

### **RIGHT TO RECEIVE AN ACCOUNTING OF CERTAIN DISCLOSURES OF YOUR PHI**

This right applies to disclosures for purposes other than treatment, payment or healthcare operations as described in this Notice of Privacy Practices. It excludes disclosures Davis County may have made to you, to family members or friends involved in your care, or for notification purposes. You have the right to receive specific information regarding these disclosures that occur after April 14, 2003.

### **RIGHT TO OBTAIN A PAPER COPY OF THIS NOTICE**

You have the right to obtain a paper copy of this notice, upon request, even if you have agreed to accept this notice electronically.

### **DAVIS COUNTY'S DUTIES AND OTHER INFORMATION**

Davis County is required by law to maintain the privacy of PHI and to provide you with this notice of our legal duties and privacy practices with respect to PHI, and abide by the terms of the notice currently in effect.

We must inform you of any breach of your PHI that compromises your PHI and that is held or transmitted in an unsecured manner, within 60 days after we discover, or by exercising reasonable diligence, should have discovered the breach.

We reserve the right to change our policies and practices regarding how we use or disclose PHI, or how we will implement Individual rights concerning PHI. We reserve the right to change this notice and to make the provisions in our new notice effective for all information we maintain. If we change these practices, we will publish a revised Notice of Privacy Practices. The revised notice will be posted and available at our places of service.

## **COMPLAINTS**

You may file a complaint to Davis County or to the Secretary of Health and Human Services if you believe your privacy rights have been violated by Davis County. You may file a complaint against Davis County by notifying Davis County Privacy Officer. Davis County will not retaliate against you for filing a complaint.
