The Davis County Board of Supervisors met in regular session on Monday, July 15, 2019, with Chairman Alan Yahnke and Members Matt Greiner and Ron Bride present.

Ron Bride made motion, seconded by Matt Greiner and carried unanimously, to approve the agenda.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Monday, July 8, 2019; Ron Bride abstained as he was absent last week.

The Board met with custodian Randy Norman, and he reported that the green benches in the courtyard are being repainted; Ron Bride reported that the courthouse clock should be repaired by the time RAGBRAI riders are here next week.

The Board met with Engineer Ryan Schock, who reported that crews have been working on crossroad pipes in anticipation of FEMA funding; C. William Brown bridge will be open Wednesday, Vaughn Proctor bridge to be open today or tomorrow, Sheriff bridge now open, and Bremer bridge should be open by next week. Contract has been signed with Bloomfield Bridge & Culvert for the Beechwood Avenue bridge.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve the Sheriff's quarterly report.

The Board met with Main Street Director Tammy Roberts, who requested use of the courtyard for National Night Out event on August 6, with rain date of August 7 and a Fall Festival event on September 28, to include a car show and pumpkin weigh-off.
