The Davis County Board of Supervisors met in regular session on Monday, May 2, 2016, with Chairman Matt Greiner and Member Ron Bride present.

During public comments, Sam Glosser questioned the Board about road grading and bridges.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

Member Dale Taylor arrived; Ron Bride made motion, seconded by Dale Taylor and carried unanimously, to approve and sign the Minutes of Monday, April 25, 2016.

The Board met with Secondary Roads; Assistant Engineer Ryan Schock reported that paving will begin this week on the airport road bridge and Quill bridge work continues. There was a question about vacation hour carry-over and whether \$100,000 rock contract can be approved each spring. Funding agreement for Robin Boulevard bridge was signed; the county yard auction was set for May 24 at 4:00 p.m.; and a request was received for speed limit sign on Nettle Avenue.

Ron Bride made motion, seconded by Dale Taylor and carried unanimously, to approve building a handicap ramp at the DHS building for an estimated cost of \$4,595.

After discussion, Ron Bride made motion, seconded by Dale Taylor and carried unanimously, to approve giving the old air conditioners stored in the DHS building to the Davis County Agricultural Society.

Dale Taylor made motion, seconded by Ron Bride and carried unanimously, to approve renting office space at the DHS building to SIEDA for \$350.00 per month, with contract yet to be approved.

Phone conference was held with Kirby Moss concerning annual insurance renewal; no action taken.
