The Davis County Board of Supervisors met in regular session on Monday, May 17, 2021, with Chairman Matt Greiner and Member Ron Bride present.

Ron Bride made motion, seconded by Matt Greiner and carried unanimously, to approve the agenda.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, May 10, 2021.

The Board met with custodian Randy Norman, who confirmed that the basement renovation has been completed, and are now open to the public. He asked that the Board consider the present South entrance to the basement, and the condition of those steps also, before finalizing the financial plans for lower level accessibility.

The Board met with Engineer Ryan Schock, who reported that work had been done to a driveway on Nettle Ave., the crews had replaced a crossroad pipe on Holly Ave. and ditching was being done on a dirt road south of Locust Grove and also south of Savannah. He also stated that 1,440 ton of rock was hauled last week.

The Board met with Heidi Kuhl, from Northland Securities, to discuss the financing details for planned road improvements to 5 paved county roads.

The Board met with Tom Prosapio, construction manager for the Courthouse Accessibility Access Addition, and discussed the needs for a new transformer. There is a need to simplify the wiring scheme and also include an emergency “disconnect” feature. Ron Bride made motion, seconded by Matt Greiner and carried unanimously, to approve amending the project and hiring an electrical engineer for this design, at the cost of \$6,400.

Ron Bride made motion, seconded by Matt Greiner and carried unanimously, to approve the following Resolution adopting a regional hazard mitigation plan:

**Resolution Adopting the ADLM Regional Multi-Jurisdictional Local Hazard Mitigation Plan
(Counties of Appanoose, Davis, Lucas, and Monroe, Iowa)**

Whereas, Davis County recognizes the threat that natural hazards pose to people and property within our community; and

Whereas, undertaking hazard mitigation actions will reduce the potential for harm to people and property from future hazard occurrences; and

Whereas, the U.S Congress passed the Disaster Mitigation Act of 2000 (“Disaster Mitigation Act”) emphasizing the need for pre-disaster mitigation of potential hazards;

Whereas, the Disaster Mitigation Act made available hazard mitigation grants to state and local governments; and

Whereas, an adopted Local Hazard Mitigation Plan is required as a condition of future funding for mitigation projects under multiple FEMA pre- and post-disaster mitigation grant programs; and

Whereas, Davis County fully participated in the hazard mitigation planning process to prepare this Multi-Jurisdictional Local Hazard Mitigation Plan; and

Whereas, the Iowa Homeland Security and Emergency Management Department and the Federal Emergency Management Agency Region VII officials have reviewed the “ADLM Regional Multi-Jurisdictional Local Hazard Mitigation Plan,” and approved it contingent upon this official adoption of the participating governing body; and

Whereas, Davis County desires to comply with the requirements of the Disaster Mitigation Act and to augment its emergency planning efforts by formally adopting the ADLM Regional Multi-Jurisdictional Local Hazard Mitigation Plan; and

Whereas, adoption by the governing body for Davis County demonstrates the jurisdictions’ commitment to fulfilling the mitigation goals outlined in this Multi- Jurisdictional Local Hazard Mitigation Plan;

Whereas, adoption of this legitimizes the plan and authorizes responsible agencies to carry out their responsibilities under the plan;

Now, therefore, be it resolved, that Davis County adopts the “ADLM Regional Multi-Jurisdictional Local Hazard Mitigation Plan” as an official plan; and

Be it further resolved, Davis County will submit this Adoption Resolution to the Iowa Homeland Security and Emergency Management Department and Federal Emergency Management Agency Region VII officials to enable the plan’s final approval.

All Board members reported on committee meetings attended.
