The Davis County Board of Supervisors met in regular session on Monday, July, 2021, with Chairman Matt Greiner and Members Alan Yahnke and Ron Bride present.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Tuesday, July 6, 2021.

The Board met with custodian Randy Norman, who reported that the city would be burying the gas lines in the courtyard "alley" during the week of the 19th, so this lane would be closed off and inaccessible for vehicles during that time.

The Board met with Engineer Ryan Schock, who reported on blading, mowing, rock hauling and hoe work, being done by the county crews. He also informed the Board that Stateline Bridge Company would be working on a bridge on 170th St., and that he plans to advertise for a common laborer position soon.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve a utility permit for Rathbun Regional Water Association on Yam Blvd.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve the request, from the last meeting, for the County Road department to provide posts and the labor to set posts for 18 signs in Davis County for the Historic Mormon Pioneer Trail.

The Board met with Vince Tyson and Johnathon Tuvera, from Citizens Mutual Telephone Company, who gave a presentation on the fiberoptics/broadband coverage in Davis County, and the company's future expansion goals. Following this, financial assistance was requested from the County, to assist with achieving these goals. Mr. Tyson anticipates that, with an offering of local assistance, they would experience a greater chance to receive additional grant funding. While the Board acknowledged an interest in providing this support, via monies received from the American Rescue Plan Act grant, no immediate action was taken.

All Board members reported on committee meetings attended.
