The Davis County Board of Supervisors met in regular session on Tuesday, July 6, 2021, with Chairman Matt Greiner and Members Alan Yahnke and Ron Bride present.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, June 28, 2021.

The Board met with custodian Randy Norman, and discussed regular courthouse maintenance, and noted his appreciation of the courtyard clean-up efforts following the 4th of July pancake breakfast and parade.
