The Davis County Board of Supervisors met in regular session on Monday, August 9, 2021, with Chairman Matt Greiner and Members Alan Yahnke and Ron Bride present.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

During the time for public comments, Garmon Morse and Junior Reese informed the Board of some road deficiencies in the area of 170th St, near Belknap.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Monday, August 2, 2021.

The Board met with custodian Randy Norman, who discussed clipping the courtyard hedges and the purchase of a new electric trimmer.

The Board met with Engineer Ryan Schock, who reported that the County crews are working on the shoulders of Lilac and Nuthatch Avenues south of Bloomfield, with the gravel retriever. Other County crews have been continuing their ditching efforts, in several locations.

The Bloomfield Main Street Director, Tori Ward, requested the use of the courtyard, on the evening of August 27, 2021, for an outdoor movie event. Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve.

The Board discussed an Information Technology Grant, sponsored by the (OCIO) Office of the Chief Information Officer, and it was determined that they would not be applying for this grant, so no action was taken.

The Board discussed their recent receipt of money, through the Coronavirus State and Local Fiscal Recovery Funds, and its intended use, among other things, for assistance to child care facilities experiencing a negative economic impact due to the COVID pandemic. Ron Bride made motion, seconded by Matt Greiner to allocate \$10,000 to the Davis County Day Care, in Bloomfield, for the purchase of needed equipment. Alan Yahnke abstained from voting.
