The Davis County Board of Supervisors met in regular session on Monday, July 26, 2021, with Chairman Matt Greiner and Members Alan Yahnke and Ron Bride present.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

During the time period for public comments, Dan Wiegand, Bloomfield City Mayor, discussed the waste receptacles placed around the square and in the courtyard, and whose responsibility it is for their maintenance. He also questioned Board members about the ownership of the south Lake Fisher road ( 212<sup>th</sup> St.) west of Bloomfield, and their feelings about the possibility of granting it to the city.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, July 19, 2021.

The Board met with custodian Randy Norman, who reported that a work crew from the City of Bloomfield had completed the work of moving a gas line in the courtyard, under the paved "alley".

The Board met with Engineer Ryan Schock, who reported that the county crews were busy repairing roads damaged by the recent rains. They had done an emergency repair to a bridge on Ruby Blvd, and were doing ditching, road pipe repairs and blading.

The Board met with Kayci Knowler, representing the Bloomfield Main Street organization, who requested the use of the courtyard for the evening of Tuesday, August 3, 2021, for the "National Night Out" event, which is to promote Law Enforcement - Community relationships. Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve the request.

The Board met with Tisha Scott, Veterans Affairs Director, and discussion was held regarding the current Fiscal Year's budget, extra hours worked, and the department's Statewide Assistance grant. No action was taken.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve the Consolidated Levy report, as presented, by Auditor Linda Humphrey.

All Board members reported on committee meetings attended. Tom Prosapio also reported on his upcoming pre-construction meeting to work out details for the courthouse access project.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve the following claims to be paid:
