The Davis County Board of Supervisors met in regular session on Monday, October 11, 2021, with Chairman Matt Greiner and Members Alan Yahnke and Ron Bride present.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Monday, October 4, 2021.

The meeting scheduled with custodian Randy Norman, was cancelled.

The Board met with Engineer Ryan Schock, who reported the various work projects being undertaken by the County crews. Besides blading, hauling rock and doing patch work south of Pulaski, there are several crossroad pipes, driveways and clearing work being completed by the Track hoe, Rubber-tired hoe and Bulldozer.

The Board met with Chris Sutton, from Christner Contracting to provide a progress report on the courthouse accessibility project.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve the rescission of a resolution approved at the last Board meeting for an administrative interfund transfer, in the amount of \$150,752.06. The rescission is due to an incorrect account number.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve an administrative interfund transfer, in the amount of \$150,752.06 to facilitate the tracking of the funds for both courthouse renovations, and the American Rescue Plan Act grant funds. The resolution being as follows:

WHEREAS, It is desired to transfer monies from ARPA-American Rescue Plan Act Fund to the Capital Project Funds, as follows:

SECTION 1. The sum of \$150,752.06 is ordered to be transferred from the ARPA-American Rescue Plan Act Fund, Revenue account # 0017-1-99-9000-847000, and moved into the Capital Project Funds with \$36,650.00 entered into revenue account #1500-1-99-9100-847000 and \$114,102.06 into revenue account #1500-1-99-9100-234700, effective September 13, 2021.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve an amendment to the Bloomfield – Davis County Public Safety Commission Restated Joint Agreement.

All Board members reported on committee meetings attended.
