The Davis County Board of Supervisors met in regular session on Monday, October 18, 2021, with Chairman Matt Greiner and Members Alan Yahnke and Ron Bride present.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, October 11, 2021.

The Board met with custodian Randy Norman, and discussed general courthouse maintenance.

The Board met with Engineer Ryan Schock, who reported that road crews had hauled 3,317 tons of rock last week and are finishing some driveway repairs and ditching. There was patching done last week South of Pulaski, and line painting is planned this week for Lilac Avenue and 276<sup>th</sup> Street.

The Board met with Tom Prosapio and Chris Sutton, from Christner Contracting, for a report on the Courthouse Accessibility project. They informed the Board that they are ready to frame the building entrance and maintenance building, and also install the gas meter this week.

Discussion was held regarding the need for a repair to the HVAC system at the County Home. The service call would be at the cost of \$1,500, and possibly a repair could be done at that time. Ron Bride made motion, seconded by Alan Yahnke and carried unanimously to approve requesting a service call.
