The Davis County Board of Supervisors met in regular session on Monday, December 20, 2021, with Chairman Matt Greiner and Members Alan Yahnke and Ron Bride present.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Monday, December 13, 2021.

The Board met with Tom Prosapio for an update on the Courthouse Accessibility project. Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve 2 Change Orders for the project, totaling \$3,600. 72

The Board met with Engineer Ryan Schock, who reported on work being done by the County crews.

The Board met with Roger Wuthrich, and others, representing the Bloomfield Public Library. They provided statistics showing all 99 counties in the State of Iowa, and how much they contribute to their respective libraries. They requested that the County budget an increased amount for their donation to the Bloomfield library, for the 2022/2023 fiscal year.

The Board met with Sheriff Dave Davis, who discussed the "Back to Blue" law revision (Senate File 342). He provided documentation showing other positions comparable to his, and what the salaries currently were for those positions.

The Board reviewed the salary recommendation for all elected officials, determined by the Compensation Board, of a 27% increase.

Alan Yahnke made motion to reduce the recommendation to 3% for the Supervisors, and 4% for all other elected officials. This motion died for the lack of a second.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously to reduce that recommendation to 3% for supervisors, and to 4.5% for all other elected officials.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve all other employees, including part-time, to also receive the increase of 4.5%, except those provided for in a bargaining agreement.

The Board spoke briefly to Ashley Walkup, regarding the pending county farm lease agreement, and then decided to table any decisions until the next meeting.

The Board discussed the 28E agreement with Pathfinders Resource Conservation Development. Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve the agreement and authorize Alan Yahnke to sign it at the next meeting of that organization.

All Board members reported on committee meetings attended.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve the following claims to be paid:
