The Davis County Board of Supervisors met in regular session on Monday, December 27, 2021, with Chairman Matt Greiner and Members Alan Yahnke and Ron Bride present.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, December 20, 2021.

The Board met with Assistant to the Engineer Bret Davis, who gave a report on the work being done by the county crews. Besides hauling rock to the County facility for storage, they are ditching, replacing cross road pipes and cleaning up some edge ruts on J40 and also south of Drakesville.

The Board met with Pulaski City Clerk, J.L. Stogdill, who requested that the supervisors provide a “letter of support” to accompany a grant application, by the city, for a park project. Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to provide such a letter.

The Board met with Tom Prosapio for an brief update on the Courthouse Accessibility project.

The Board met with Assistant County Attorney, Ashley Walkup, regarding the pending County Farm lease agreement. After discussion regarding minor changes, the Board requested that Ashley advertise the bidding procedure and prepare packets for bidders. They plan to run the advertising for two consecutive weeks in both *The Bloomfield Democrat* and *The Tri-County Shopper*.
