The Davis County Board of Supervisors met in regular session on Monday, December 6, 2021, with Chairman Matt Greiner and Members Alan Yahnke and Ron Bride present.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, November 29, 2021.

The Board met with Engineer Ryan Schock, who reported on work being done by the County crews and paving projects by Norris Construction. The newly paved roads include Nuthatch Ave. (Bike Barn Road), Mink Blvd. (both the North and the South sections), and 276<sup>th</sup> Street from Hwy 63 through the town of Mark. The final road scheduled to be repaved, from Lilac Avenue to the Bloomfield Airport will not be completed until next spring.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve a resolution for a sign replacement agreement with the Department of Transportation. This agreement states that the DOT will reimburse Davis County for an amount up to \$10,000, per County, for the replacement of existing signs, whose deficiencies are eligible for replacement.

The meeting scheduled with Tom Prosapio for a report on the Courthouse accessibility project was cancelled.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously to approve a proposal from Rory DeMesy, from Mechanical Watch Supply, LLC, for repairs and maintenance needed to the Courthouse Bell. The proposal is for the amount of \$11,500, and is to be paid from the Davis County Courthouse Preservation Fund, with money allocated specifically for bell repair.

All Board members reported on committee meetings attended.
