The Davis County Board of Supervisors met in regular session on Tuesday, February 22, 2022, with Chairman Alan Yahnke and Members Ron Bride and Matt Greiner present.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, February 17, 2022.

The Board met with custodian Randy Norman, who updated the board on estimates to be provided for dead tree removal in the courtyard.

The Board met with Engineer Ryan Schock, who reported that Teasel spraying would begin again around the end of May for the same roads that were done in the previous year. The application of 2 years in a row, is necessary for Teasel eradication.

Ron Bride made motion, seconded by Matt Greiner and carried unanimously, to approve a utility permit for Rathbun Regional Water Association on 240<sup>th</sup> Street.

Ron Bride made motion, seconded by Matt Greiner and carried unanimously, to approve the cancellation of a seal coat project on V42 (South of Pulaski). The Board is hoping to provide that road with a more long-term solution.

The Board met with Tom Prosapio for an update on the Courthouse Accessibility project. Tom reported that the basement floor should be done by the end of this week.

The Board met with Linda Humphrey to discuss a project for scanning certain documents, in both the Auditor and Recorder's office, which would subsequently provide public access, via Internet, to those records. This would be paid for by using some of the American Rescue Plan Act fiscal recovery funds, provided to the County by the Federal government.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve this expenditure from this funding, for this project.

All Board members reported on committee meetings attended.
