The Davis County Board of Supervisors met in regular session on Monday, April 4, 2022, with Chairman Alan Yahnke and Members Ron Bride and Matt Greiner present.

Ron Bride made motion, seconded by Matt Greiner and carried unanimously, to approve the agenda.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, March 28, 2022.

The meeting with custodian Randy Norman, was cancelled.

The Board met with Engineer Ryan Schock, to open bids for the 2022 Rock Program. There were 11 different roads identified in the project, and 3 different bidders. Douds Stone was the least expensive bid for each of the 11 projects.

Ron Bride made motion, seconded by Matt Greiner and carried unanimously, to approve awarding the contract to Douds Stone, pending review by the Engineer for any errors in calculation.

The Engineer also stated that Norris Asphalt plans to complete a road pavement project begun last fall and interrupted by winter weather, by repaving a portion 230th Street (airport road).

Dave Gordy spoke to the Board and the Engineer about using the limited access, Class "C" road near his home to film a pilot episode for a drama that involves flashbacks to World War II. They verbally agreed to allow it, but would approve an informal contract at a later date.

The Board met with Josh Wright who was requested that they consider designating Davis County as a Second Amendment sanctuary county. There was much discussion, with contributions both for and against from several audience members. No action was taken.

At 10:00 A.M., the Board concluded the Second Reading of the Davis County Industrial Property Tax Exemption Ordinance. There were no comments offered, neither oral nor written. The third and final reading will be held at next Monday's Board meeting.

At 11:00 a.m. the Chairman called a budget amendment hearing to order. There being no public verbal or written comments, Ron Bride made motion, seconded by Matt Greiner and carried unanimously, to close the hearing. Ron Bride made motion, seconded by Matt Greiner and carried unanimously, to approve the budget amendment as previously published in *The Bloomfield Democrat* on March 23, 2022. Matt Greiner made motion, seconded by Ron Bride and carried unanimously, with the roll call vote being: Matt Greiner – Aye, Ron Bride – Aye, Alan Yahnke - Aye, to the following Amendment to the Appropriations Resolution:
