The Davis County Board of Supervisors met in regular session on Monday, January 17, 2022, with Chairman Alan Yahnke and Members Ron Bride and Matt Greiner present.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

A citizen inquired about the Board's thoughts on the 2A Sanctuary.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, January 10, 2022 and Thursday, January 13, 2022.

The Board met with custodian Randy Norman, who discussed routine maintenance and snow removal issues.

The Board met with Engineer Ryan Schock, who reported on the snow removal efforts by the road crews over the weekend.

The Board met with Tom Prosapio for an update on the Courthouse Accessibility project. He reported that there is exterior ground finishing and the State lift inspection yet to be completed before the lift will be available for use.

The Board discussed the position of Veteran's Affairs Director and a possible adjustment to the regular work hours. After much discussion, the issue was tabled until next Monday's meeting.

The Board met with Dawn McCarty, from the Davis County Care/Optimae facility. She introduced Zach Hale, who is currently their new maintenance employee. She also discussed an insurance claim filing for a recent water damage event in one of the floors in an office.

Ron Bride made motion, seconded by Matt Greiner and carried unanimously, to approve a resolution agreeing to apply for financial assistance with the United States Department of Agriculture, Rural Development to finance a Radio Communications Tower, and authorizing Alan Yahnke, as Board Chairman, and Davis County Auditor, Linda Humphrey to sign all documents relating to the USDA Rural Development loan and/or grant.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve inclusion of Secondary Road employees in the 4.5% pay increase that was previously approved for other County employees. Therefore, the bargaining agreement between the County and PPME was extended to June 30, 2023.
