The Davis County Board of Supervisors met in regular session on Monday, July 18, 2022, with Chairman Alan Yahnke and Members Ron Bride and Matt Greiner present.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

Ron Bride made motion, seconded by Matt Greiner and carried unanimously, to approve and sign the Minutes of Monday, July 11, 2022.

The Board met with custodian Randy Norman, who reported that the new flooring installation in the courtroom has been completed.

The Board met with Engineer Ryan Schock, who presented some gravel price comparisons from local rock quarries. He also reported that a damaged section of pavement on J40, near the Timber Avenue intersection has been repaired with concrete.

After consideration by the Board, Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve “Go Gourmet” to use the electricity on the north side of the courtyard for a special food event on July 29th & 30th.

Ron Bride made motion, seconded by Matt Greiner and carried unanimously, to approve the Consolidated Levy Report as prepared by the County Auditor.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to deny the approval of 1 (one) Homestead credit application as recommended by the County Assessor, Lois Heckethorn. Ron Bride made motion, seconded by Matt Greiner and carried unanimously, to approve all other Homestead, Disabled Veteran Homestead and Military credit applications per the recommendation of the County Assessor.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve 2 (two) applications to receive American Rescue Plan Act funds. One from the Davis County Sheriff’s Department for the purchase of bullet-proof shields for their officers, in the amount of \$12,204.00. The second application is for \$5,000.00, requested by The Friends of Lake Wapello group, which will use this to complete their financing goal to build a shelter house near the walking trail at the lake.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve an “assignment of tax sale certificate” for Parcel 13077830 a.k.a. 214 S. Second St. in Pulaski, as presented by the Assistant County Attorney Ashley Walkup, to the City of Pulaski.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to table the agenda item regarding the approval of the Treasurer's Semi-Annual report.

All Board members reported on committee meetings attended.
