The Davis County Board of Supervisors met in regular session on Tuesday, July 5, 2022, with Chairman Alan Yahnke and Members Ron Bride and Matt Greiner present.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

There were no comments contributed by the public.

Ron Bride made motion, seconded by Matt Greiner and carried unanimously, to approve and sign the Minutes of Monday, June 27, 2022.

The Board met with custodian Randy Norman, who reported that he had been watering some younger trees in the courtyard, due to the dry conditions.

The Board met with Secondary Roads Maintenance Supervisor Mike Conley, in the absence of the Engineer, who reported that the County crews were blading, mowing, hauling rock and ditching. He also stated a request that money be budgeted for new fuel pumps and a rubber-tired hoe.

The Board met with Mike Lamb, Emergency Management Director, to discuss the County's possible participation in the National Flood Insurance Program. No action was taken.

The Board met with Heidi Kuhl from Northland Securities, to discuss funding for a road pavement project on a portion of Timber Avenue. No action was taken.
