The Davis County Board of Supervisors met in regular session on Monday, June 27, 2022, with Chairman Alan Yahnke and Members Ron Bride and Matt Greiner present.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

There were no public comments offered.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, June 20, 2022.

The Board met with custodian Randy Norman, who reported that the Air Conditioning unit in the Auditor's office had been replaced, and both the hand railing on the east steps of the courthouse, and some damaged sidewalk areas had been repaired.

The Board met with Engineer Ryan Schock, who reported on general maintenance being done by the county crews. They discussed the cost of road stone from the available vendors.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Fiscal Year 2023 Service Agreement between the Davis County Hospital and the Davis County Board of Health.

Ron Bride made motion, seconded by Matt Greiner and carried unanimously, to approve and sign a letter of support for the Davis County Trails Council. The Council is hoping to pursue grant funding, in an effort to complete a multipurpose trail system.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve fiscal year 2023 appropriations and prorated funding estimates for the Homestead & Disabled Veterans Tax Credit, Elderly and Disabled Tax Replacement Credit, and Military Service Tax Credit at 100%. Prorated funding for Ag Land Tax Credit was approved at 20.4037288% and Family Farm Tax Credit at 14.4522343%.

The Board discussed the County's possible participation in the National Flood Insurance Program. No action was taken.

All Board members reported on committee meetings attended.
