The Davis County Board of Supervisors met in regular session on Monday, August 29, 2022, with Chairman Alan Yahnke and Members Ron Bride and Matt Greiner present.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

Ron Bride made motion, seconded by Matt Greiner and carried unanimously, to approve and sign the Minutes of Monday, August 22, 2022.

The Board met with custodian Randy Norman, who reported that he would be installing a cabinet, to house computer wiring, in the Clerk of Court's back office per the State's request.

The Board met with Engineer Ryan Schock, who reported on the blading, mowing, hauling rock and ditching being done by the County crews. He also noted that their summer work hour schedule would end and their regular schedule would return to 5 - 8 hour days on September 15, 2022.

Ron Bride made motion, seconded by Matt Greiner and carried unanimously to approve Kristi Goodson to the position of Deputy Auditor with an accompanying pay increase, per the Auditor's request, effective September 1, 2022.
