The Davis County Board of Supervisors met in regular session on Monday, September 12, 2022, with Chairman Alan Yahnke and Members Ron Bride and Matt Greiner present.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

Ron Bride made motion, seconded by Matt Greiner and carried unanimously, to approve and sign the Minutes of Tuesday, September 6, 2022.

The Board met with custodian Randy Norman, and discussed general courthouse maintenance.

The Board met with Engineer Ryan Schock, who reported on work being completed by County crews and contracted projects for crack sealing on 195<sup>th</sup> Street and some roads leading to Drakesville, and also slurry work scheduled for the Floris road, the fairgrounds road and J40.
