The Davis County Board of Supervisors met in regular session on Monday, October 10, 2022, with Chairman Alan Yahnke and Member Matt Greiner present. Vice Chairman Ron Bride was absent.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

The approval of the minutes from the meeting on Monday, October 3, was postponed due to not enough attendees of that meeting being absent.

The Board met with Engineer Ryan Schock, who reported on the blading, mowing, hauling rock and ditching work being done by the County crews. They are also replacing some crossroad pipes and using a bulldozer to clear brush on a dead end road.
