The Davis County Board of Supervisors met in regular session on Monday, October 3, 2022, with Chairman Alan Yahnke and Member Ron Bride present. Member Matt Greiner was absent.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, of Monday, October 3, 2022.

The Board met with custodian Randy Norman, and discussed landscaping planned for around the maintenance shed in the courtyard.

The Board met with Engineer Ryan Schock, who reported that the County crews were mowing, hauling rock and ditching. The rubber-tired hoe operator had replaced 2 driveways south of Pulaski last week and will move to Wheat Avenue to complete 2 driveways and 2 crossroad pipe replacements there. The Engineer also stated that the use of one motor grader had been lost due to a damaged motor. He discussed with the Board some available options for repair or replacement. No action was taken.

At 10:00 a.m., Chairman Alan Yahnke opened a public hearing for a budget amendment to the fiscal year 2022-23 budget. Due to there being no oral or written comments, Ron Bride made motion, seconded by Alan Yahnke and carried unanimously to approve closing the hearing.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously to approve the budget amendment as previously published in *The Bloomfield Democrat*.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously by roll call vote of Ron Bride – Aye, and Alan Yahnke – Aye, to approve an amendment to the Appropriations Resolution as follows:
