The Davis County Board of Supervisors met in regular session on Monday, November 21, 2022, with Chairman Alan Yahnke and Members Ron Bride and Matt Greiner present.

Ron Bride made motion, seconded by Matt Greiner and carried unanimously, to approve the agenda.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, 14, 2022.

The Board met with custodian Randy Norman, and reported that the Christmas lights are scheduled to be put up this week. He also told them that he is waiting to receive an estimate for the work needing done at the 203 S. Madison building.

The Board met with Engineer Ryan Schock, who reported on work projects being done by the County crews. The Engineer then presented some utility permits for the Board to consider.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously to approve a utility permit to Rathbun Regional Water Association for a location on 210<sup>th</sup> Street.

Ron Bride made motion, seconded by Matt Greiner and carried unanimously, to approve 2 utility permits to Citizens Mutual Telephone Company, one for a location on 155<sup>th</sup> St. and one for a location on Yak Ave.

The Board met with Diane Bales and Joy Lore-Lawson, representing the Davis County Tourism group. They explained the financial struggles facing the Davis County Welcome Center, and requested that the Board consider them as they begin their budgeting process for the upcoming fiscal year.

The Board reviewed a Request for Proposal, for the Southeast Davis County Broadband (CDBG) Community Development Block Grant Project. Matt Greiner made motion, seconded by Ron Bride and carried unanimously to approve.
