The Davis County Board of Supervisors met in regular session on Monday, December 12, 2022, with Chairman Alan Yahnke and Members Ron Bride and Matt Greiner present.

Ron Bride made motion, seconded by Matt Greiner and carried unanimously, to approve the agenda.

Public comments were offered regarding the poor location of a road culvert and the possibility of its relocation. The engineer will investigate any possible options to correct this.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, December 5, 2022.

The Board met with custodian Randy Norman, and discussed the repairs to the ceiling inside the Veterans Affairs building at 203 S. Madison St. They also discussed the possibility of creating a semi-private employee lunch area in the courthouse basement.

The Board met with Engineer Ryan Schock, who reported on work being done by the County crews. Besides blading and hauling rock, the rubber-tired hoe will be clearing brush on Jade Ave, south of Drakesville, and the track hoe is cutting brush on Venus Trail.

Davis County Treasurer, Mike Johnson, presented the Board with a request to increase the salary of one of his office deputies to the full amount allowed by statute, of 85% of his salary. The board opted to officially authorize this request at the time of budget approval.

Davis County Recorder, Megan Clyman, presented the Board with a check for \$10,000 from the Davis County Community Foundation. It was procured by the Davis County Historical Preservation Commission as a contribution to construct a new courtyard gazebo.

The Board discussed the financial concerns of the Mutchler Community Center. No action was taken.

All Board members reported on committee meetings attended.
