The Davis County Board of Supervisors met in regular session on Monday, December 19, 2022, with Chairman Alan Yahnke and Members Ron Bride and Matt Greiner present.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

There were no comments offered by the public.

Ron Bride made motion, seconded by Matt Greiner and carried unanimously, to approve and sign the Minutes of Monday, December 12, 2022.

The Board met with custodian Randy Norman, who reported that the machines for the record book scanning project were currently being set up in the courthouse basement.

The Board met with Engineer Ryan Schock, who reported on the work being done by the County crews. He gave the Board pricing information regarding the purchase of rock and hauling from the local quarries, fuel and new road blading machines.

The Board met with members Roger Wuthrich and Shannon Vesley from the Bloomfield Public Library Board, who provided statistics of past patron usage of the library and also their prospective budget for the next fiscal year. They requested that the Board consider increasing their contribution to the library in the next County budget.

The Board reviewed the salary recommendation from the Davis County Compensation Board, for elected officials, of a 48% increase.

Matt Greiner made motion to reduce the recommendation to 3% for all elected officials. This motion died for the lack of a second.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to reduce that recommendation to 3% for the Supervisors and 5% for all other elected officials.

Matt Greiner made motion, seconded by Ron Bride to approve all other employees, including part-time, to also receive the increase of 5%, except for those provided for in a bargaining agreement. The motion passed with the vote as follows: Matt Greiner, Aye, Ron Bride, Aye, and Alan Yahnke, Nay.

All Board members reported on committee meetings attended.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve the following claims to be paid:
