The Davis County Board of Supervisors met in regular session on Monday, February 27, 2023, with Chairman Ron Bride and Members Alan Yahnke and Dave Henderson present.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

No comments were offered by the public.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Tuesday, February 21, 2023.

The Board met with custodian Randy Norman, who discussed regular courthouse maintenance.

The Board met with Engineer Ryan Schock, who reported that the cost of dust control will be increasing for this summer season. The firm of Binns & Stevens is raising their prices to County residents from \$443 last year to \$612 for this season. Heffron's rates will grow from the previous years' cost of \$515 to \$595. The Engineer also stated that he is searching for affordable resurfacing options for the Floris road and the road east of Drakesville.

The Board met with County Recorder Megan Clyman, representing the Davis County Historic Preservation Commission to present their annual CLG (Certified Local Government) report.

The Board met, via telephone, with Steven Preader, from Sagacity Benefits, a World Company, regarding a different option to the County's self-funded Employee Health Plan. After discussion, Alan Yahnke made motion, seconded by Dave Henderson and carried unanimously to sign a letter and fill out other necessary paperwork, in order to pursue a quote from them.

The Board held discussion regarding the appointment of a county resident, acting as a representative of the County, to the Mutchler Community Center Commission. Ron Bride made motion, seconded by Alan Yahnke and carried unanimously to approve Ashley Utt to be that representative for a 3-year term, retroactively beginning on January 1, 2023 and ending December 31, 2025.

The Board met with County Treasurer Mike Johnson, concerning an office renovation project which would make his office ADA (American Disabilities Act) compliant. He provided the Board with a cost estimate to make those changes, in the amount of \$19,483.25. Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve the project and to pay for it with funding, received by the County, from the American Rescue Plan Act.

The Board discussed signing a letter of support for a “Future Ready Iowa Summer Youth Internship” program grant for Davis County Emergency Medical Services and to provide for the Worker’s Compensation Insurance for any individuals participating in the program in Davis County. Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to sign the letter and provide the necessary insurance.

All Board members reported on committee meetings attended.

Alan Yahnke made motion, seconded by Dave Henderson and carried unanimously, to approve the following claims to be paid:

The passage of this law requires that all Counties now repeat their “Valuations” process, before completing their budgets. The Auditor will complete this process again and then the Board will move forward with budgeting.
