The Davis County Board of Supervisors met in regular session on Monday, March 13, 2023, with Chairman Ron Bride and Member Dave Henderson present. Member Alan Yahnke was absent.

Dave Henderson made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

During the time set aside for public comments, Don Walton addressed the Board regarding the Mutchler Community Center and his concerns over the appointments of new commission members. No action was taken.

Dave Henderson made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, March 6, 2023.

The Board met with custodian Randy Norman, who noted that the document scanning project, being conducted in the courthouse basement, has been completed and the basement has been returned to its former state.

The Board met with Engineer Ryan Schock, who reported on the projects being done by the County crews. He also stated that he would be having a “pre-construction” meeting with Norris Asphalt on Tuesday, March 21st, regarding the V42 (Timber Avenue) paving project south of Pulaski.

Dave Henderson made motion, seconded by Ron Bride and carried unanimously to approve a utility permit for Citizens Mutual Telephone Cooperative for a Broadband project on Wheat Avenue.

Dave Henderson made motion, seconded by Ron Bride and carried unanimously to approve a “Resolution To Authorize the Submittal of a Traffic Safety Fund Application” to the Iowa Dept. of Transportation for portable traffic signal trailers, and to authorize the chairperson to sign the grant application and assume responsibility and ensure proper maintenance of any new or improved installations.

Dave Henderson made motion, seconded by Ron Bride and carried unanimously to approve an application submitted for use of a portion of the American Rescue Plan Act fiscal recovery funds, provided to the County by the Federal government, for the V42 (Timber Avenue) paving project South of Pulaski, in the amount of \$586,884.

The Board members reported on committee meetings attended. All three Supervisors attended the ISAC (Iowa State Assoc. of Counties) Spring Conference, as well as the County Auditor, Recorder and Treasurer for participation in educational seminars, in Des Moines, last week.
