Alan Yahnke made motion, seconded by Dave Henderson and carried unanimously, to approve the agenda.

No public comments were offered.

Alan Yahnke made motion, seconded by Dave Henderson and carried unanimously, to approve and sign the Minutes of Monday, February 27, 2023.
