The Davis County Board of Supervisors met in regular session on Monday, March 27, 2023, with Chairman Ron Bride and Members Alan Yahnke and Dave Henderson present.

Alan Yahnke made motion, seconded by Dave Henderson and carried unanimously, to approve the agenda.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Monday, March 20, 2023.

The Board met with custodian Randy Norman, who reported that the electricity had been disconnected from the courtyard gazebo. He also noted that the flag was immovable on the north flagpole. It will require a boom truck or lift to repair the problem and it may have to wait until the ground is drier and more stable.

The Board met with Engineer Ryan Schock, who reported that the County crews were blading, hauling rock and using the track hoe to cut brush. Currently brush was being cut on Owl Ave. and Monarch Trail. Ryan noted, too that Norris Construction will begin working on Timber Ave. south of Pulaski on Monday, April 3<sup>rd</sup>.

Alan Yahnke made motion, seconded by Dave Henderson and carried unanimously, to approve the Fiscal Year 2024 County 5 Year Plan as presented by the Engineer.

The Board discussed the Recreation Trail and snow removal for the Davis County portion of the trail. No action was taken.

The Board discussed a request by Bloomfield Main Street to incorporate a few baby animals with the addition of a “Farming is Fun” experience to be included at the June 10<sup>th</sup> Farmer’s Market event in the courtyard. After discussion, Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve this to be added to the event.

All Board members reported on committee meetings attended.
