The Davis County Board of Supervisors met in regular session on Monday, May 1, 2023, with Chairman Ron Bride and Members Alan Yahnke and Dave Henderson present.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Monday, April 24, 2023.

The Board met with custodian Randy Norman, who reported that the gazebo had been removed from the courtyard. He also presented an estimate from MJ's Countryscapes for dirt work and landscaping finishes in the courtyard.

The Board met with Engineer Ryan Schock, who reported that a 2-day training had been conducted to provide information and support to road maintainer drivers.

The Board discussed the possibility of implementing an ordinance for the purpose of keeping the County Right-of-Ways clear and potentially attaching fines if violated. No action was taken.

The Board met with Junior Reese and Steven O'Grady, from the Veteran's Affairs Commission, who shared information about the hiring of Laura Baird as the new administrator for the office of Veteran's Affairs/General Assistance. Alan Yahnke made motion, seconded by Dave Henderson and carried unanimously to approve the new hire, with her starting date to be Monday, May 8, 2023.

The Board held discussion regarding the Davis County Employee Health Plan renewal for Fiscal Year 2023-2024. No action was taken.
