The Davis County Board of Supervisors met in regular session on Monday, June 5, 2023, with Chairman Ron Bride and Members Alan Yahnke and Dave Henderson present.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

There were no public comments offered.

Alan Yahnke made motion, seconded by Dave Henderson and carried unanimously, to approve and sign the Minutes of Tuesday, May 30, 2023. Ron Bride abstained from voting, since he did not attend that meeting.
