The Davis County Board of Supervisors met in regular session on Monday, July 24, 2023 with Chairman Ron Bride and Members Dave Henderson and Alan Yahnke present.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Alan Yahnke made motion, seconded by Dave Henderson and carried unanimously, to approve and sign the Minutes of Monday, July 17, 2023.

The Board met with custodian Randy Norman, who commented that the remodel of the Treasurer's office, by J & S Construction, was now complete. The Board also discussed their plans for the dirt work to be done around the new gazebo/bandstand in the courtyard. They hope to be able to spread the lawn seeding this fall.

The Board met with Engineer Ryan Schock, who reported on the activities of the County crews. Even without the needed moisture, the blade operators are working on heavily "wash-boarded" areas on some gravel roads. The Engineer also stated that the "Ritz" bridge on Lilac Avenue will be closed for about a week while it receives a new deck overlay. That is expected to begin this week.
